Program Quality Assessment


Tool developed by CYPQ used by programs to complete a self assessment

Pyramid of Program Quality




Quality Programming Includes:

Youth Engagement
Peer Interaction
Supportive Environment
Safe Environment





Beliefs of CYPQ:



- Assess Observe what is actually going on in our program & collect OBJECTIVE data
- 2. Plan What changes need to be implemented & how do we implement these changes?
- 3. Improve Controlled change

Self-Assessment Tool:

What?

Tool that will allow the staff at each site to look at their program in the areas of:

- Youth Engagement
 - Peer Interaction
- Supportive Environment
 - Safe Environment

You decide what areas the program excels in and what areas need improvement.

How?

- Divided into categories and then sections
 - Can earn a score of 5, 3, or 1 in each section
 - One anecdote (objective piece of evidence or date) must be provided to support each score given

Who?

All program staff at each site = assessment tool

Important for all staff to understand to to learn how to use.

When?

Must be completed by deadline that CYPQ and Sonja put forth. The deadlines are non-negotiable!

Data collection starts NOW and is ALWAYS happening!

Where?

Data collections needs to happen during all portions of program:

- Dinner - General Session - Enrichment - Clubs

Why?

Higher scores lead to higher levels of youth engagment.

High quality programming --> efficacy, communication, empathy, and problem solving

Data collected is used to develop the program improvement plan (PIP)

How do we start the process of Self-Assessment?

- Observations & Note-Taking
- Entire assessment team responsible
- Might be good idea to keep post its or index cards with you
- Avoid using names use first letter of name: student A, activity facilitator J
- -Remeber to write down what you SEE & HEAR NOT what we'd like to see or hear
 - One anecdote may be used in more than one place


Anecdotes:



- Start with a snapshot, statement, when it was happening, where it is happening
 Describe the actions of students and staff (do not use names, use intials)
 Use exact quotes, if you have some, and exact actions.
- 3. Avoid Personal Opinions, feelings, and thoughts
